IV. PROCLAMATION OF ELECTED TRUSTEES

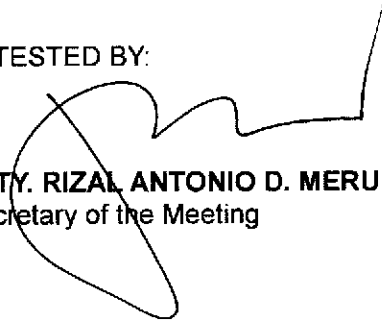
Since the election was uncontested, the said eight (8) nominees were proclaimed by the presiding officer as duly elected members of the Board of Trustee for 2025-2026.
